Affordable multifamily buildings with 5 or more units in Kansas City, Missouri are eligible to receive services at no cost. Affordability is defined as:

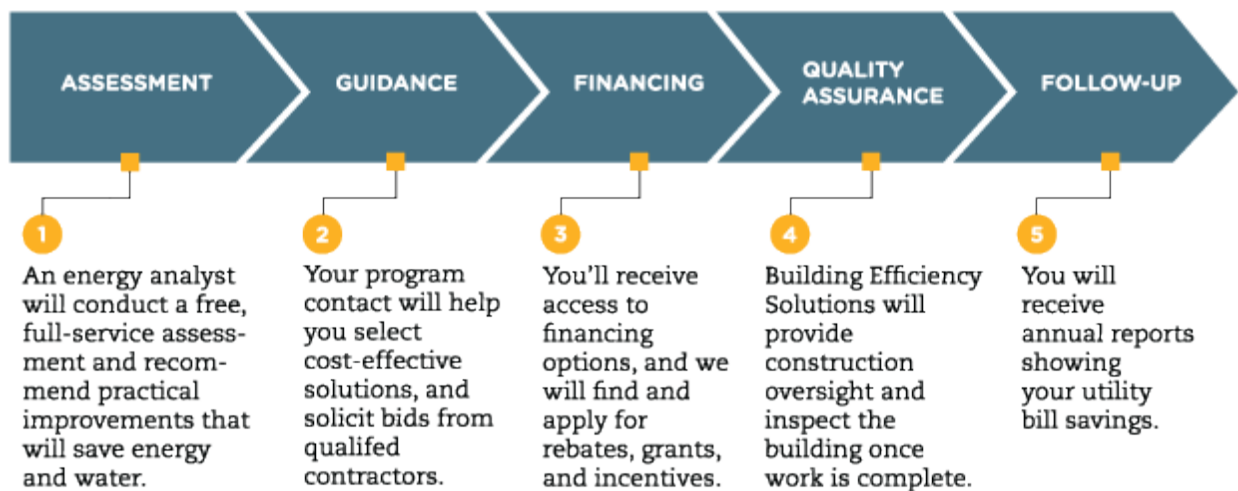
- Receives federal and/or state housing subsidies (including HUD vouchers, LIHTC, etc.)
- Rent is affordable to families at or below 80% of Area Median Income, or less than \$1,025 per month
